- 5) GSFC University shall ensure to fulfil all safety and security related compliances of the Zeppelin Systems India Pvt Ltd during the period of Industrial Internship and shall cover all the students under the Group accident Insurance Policy for an amount of Rs. 1.00 Lakhs for each student.



6) This MOU has been executed with the sole purpose of establishing an industry linkages of the University with Zeppelin Systems India Pvt Ltd without creating any legal obligation on either party to this MOU.
