



MEMORANDUM OF UNDERSTANDING (MOU) FOR INDUSTRIAL INTERNSHIP /CAMPUS PLACEMENT.

GSFC UNIVERSITY is a Private University set up under the Gujarat Private Universities Act, 2009, having its registered office at P.O. Fertilizernagar Pin 391750 Dist. Vadodara, Gujarat and promoted by Gujarat State Fertilizers & Chemicals Limited (GSFC).

GSFC University has introduced a unique practice of providing intensive Industrial Internship for every student in each semester with an objective of making them Industry ready and employable.

Therefore, GSFC University has approached Mai Krupa Industry having its registered office Patan Vadid Vaga Karachiya Vadodara Gujarat 391310 with a request to provide the Industrial Internship as per the Students Industrial Internship Manual of the University.

Considering the request of GSFC University, Mai Krupa Industry has agreed in principle to provide the Industrial Internship to the students.

In view of the above, this MOU has been executed on the following terms and conditions;

- 1) Mai Krupa Industry is hereby agreed in principle to provide the Industrial Internship as per the Students Industrial Internship Manual of the University, a copy of the which is attached herewith as Annexure - A.
- 2) GSFC University shall approach Mai Krupa Industry at least 30 days prior to commencement of Industrial Internship.
- 3) The exact number of students will be decided mutually by both the parties having regard to the recourses and facilities available with the Mai Krupa Industry from time to time.
- 4) GSFC University and Mai Krupa Industry shall appoint a Faculty mentor and Industry mentor as per the Students Industrial Internship Manual for effective implementation of the Industrial Internship.
- 5) GSFC University shall ensure to fulfil all safety and security related compliances of the Mai Krupa Industry during the period of Industrial Internship and shall cover all the students under the Group accident Insurance Policy for an amount of Rs.1.00 Lakhs for each student.



6) This MOU has been executed with the sole purpose of establishing an industry linkages of the University with Mai Krupa Industry without creating any legal obligation on either party to this MOU.

Besides Industrial Internship, we may also associate with GSFC University to conduct Expert Talk/Placement Drive/Campus Placement as and when required without any obligation on either party.
