



MEMORANDUM OF UNDERSTANDING (MOU) FOR INDUSTRIAL INTERNSHIP /CAMPUS PLACEMENT.

GSFC University has introduced a unique practice of providing intensive Industrial Internship for every student in each semester with an objective of making them Industry ready and employable.

Therefore, GSFC University has approached Way To Web Pvt Ltd. having its registered office 405, 3rd EYE Building-2, Above McDonald's Nr. Joyalukkas Opp: Primal Garden Ahmedabad with a request to provide the Industrial Internship as per the Students Industrial Internship Manual of the University.

- 4) GSFC University and Way To Web Pvt Ltd. shall appoint a Faculty mentor and Industry mentor as per the Students Industrial Internship Manual for effective implementation of the Industrial Internship.
- 5) GSFC University shall ensure to fulfil all safety and security related compliances of the Way To Web Pvt Ltd. during the period of Industrial Internship and shall cover all the students under the Group accident Insurance Policy for an amount of Rs. 1.00 Lakhs for each student.



6) This MOU has been executed with the sole purpose of establishing an industry linkages of the University with Way To Web Pvt Ltd. without creating any legal obligation on either party to this MOU.

Besides Industrial Internship, we may also associate with GSFC University to conduct Expert Talk/Placement Drive/Campus Placement as and when required without any obligation on either party.
